Terms and Conditions

IMPORTANT: PLEASE READ THESE TERMS AND CONDITIONS BEFORE ENTERING CHEAPOAIR'S TRAVEL OF THE YEAR AWARD (THE "CONTEST"). BY SUBMITTING AN ENTRY, YOU AGREE TO BE BOUND BY THESE TERMS AND CONDITIONS AND WARRANT THAT YOU WILL COMPLY WITH ALL THE REQUIREMENTS SET FORTH HEREIN THROUGHT THE CONTEST.

I. Contest Description

The Contest begins July 23rd, 2012 at 10 a.m. (EST) and ends December 13th, 2012 at 10 a.m. (EST) ("Contest Period"). To participate in this Contest, CheapOair invites you to submit a video maximum three to five minutes in length, for consideration to be placed on the http://contests.cheapoair.com/traveler-of-the-year-2012 website ("the Site") for public voting. Entries are accepted July 23rd, 2012 at 10 a.m. (EST) to August 19th, 2012 at 10 a.m. (EST) ("Entry Period"). To be eligible for consideration, each submitted video should address one of the following topics:

- 1. Give us a tour of your favorite city, landmarks, etc.
- 2. What do you do to travel the world for less?
- 3. Did you walk across America? Have a significant impact on a foreign culture? We would love to hear about it.
- 4. Are you an adventure seeker that travels to amazing destinations? Pump up our adrenaline with some exciting adventure footage. Just remember we want to know you as well.

("Entry Video")

Ten (10) Semifinalists will be chosen by CheapOair based on the relevancy of the video, challenges provided in the footage, cultural events described, the inventiveness, quality, and authenticity of the Entry Videos. The Semifinalists' submitted videos shall then be published on the Site for public voting starting with September 4th, 2012 at 10 a.m. (EST) until September 21st, 2012 at 5 p.m. (EST). CheapOair reserves the right to increase the number of accepted Semifinalists, at its own discretion, prior to September 4th, 2012.

Two (2) Finalists will be announced on September 24th at 6 p.m. (EST) based on the number of votes received. Each of the two Finalists shall then be provided the opportunity to travel to a destination chosen by CheapOair for a maximum of thirty (30) days starting with October 12th ("Travel Period"). For this purpose, CheapOair will provide the required airfare and an allowance of \$250/day to cover the hotel costs, meals and other travel related costs ("Allowance")

Prior to the Travel Period, and as a condition precedent for a Finalist to claim any prize, each Finalist shall sign and remit to Cheapoair a release form as provided by CheapOair. During the Travel Period, the Finalists will be required to perform certain tasks and/or participate in certain challenges as will be determined by CheapOair, in its sole discretion, which may include without limitation skydiving, scuba diving, snorkeling, hang gliding, cliff jumping, mountain climbing, kayaking, zip lining, dune buggy racing("Required tasks").

At the end of the Travel Period, each Finalist will be required to present a 10 minute high quality video, highlighting the finalists experience during the Travel Period, that would include the following:

- 3. Mixed in music.

("Travel Video") by November 19th, 2012 at 10 a.m. (EST) The Video will only published in the Site for public voting if approved by CheapOair. Depending on the number of votes, a Winner shall be announced on December 11th, 2012 at 5 p.m. (EST). If both Finalists have the same number of votes, the Winner shall be decided by CheapOair.

II. Eligibility

Entrants must be legal residents of the 50 United States (including the District of Columbia but excluding Puerto Rico and all other U.S. and foreign territories and possessions), and be twenty-one (21) years or older as of the date of entry.

To be eligible to participate in this Contest, in addition to submitting an Entry Video, each contestant must submit an entry form which may require you disclose personal information, such as name, e-mail, phone number, address, and comply with all the eligibility criteria set forth herein.

Contestants must have the legal right and any and all permissions necessary to submit the Entry Videos and shall grant all right to the Entry Videos to CheapOair. By participating in this Contest, you warrant and agree that you have all the rights necessary to enter and participate in this Contest and grant CheapOair all the rights described herein.

Employees of CheapOair and its affiliates, subsidiaries, distributors, retailers, advertisers, and other coordinating agencies participating in the execution of this contest and their immediate family members are not eligible to enter this contest. This contest is subject to all federal, state and local laws and regulations. III. Entries, Entry Videos and Travel Videos ("Contest Materials")

During the Entry Period, upload your video on http://contests.cheapoair.com/traveleroftheyear and complete the registration form found at http://traveleroftheyear.cheapoair.com/register.php. There is a limit of one entry per contestant. There is no entry fee and no additional purchase is necessary.

All Contest Materials must be original and may not contain material that violates or infringes any third party's rights, including without limitation intellectual property rights, privacy and/or publicity rights. The Entry Videos must be developed in high quality, and shall not contain any content that is obscene or indecent, and shall not include profanity, references to drugs or alcohol, or words or expressions that may be interpreted as offensive to individuals of specific race, religion, ethnicity, social orientation, or other content deemed inappropriate by CheapOair, at its sole discretion. In the event an Entry Video is deemed inappropriate, that Entry shall be ineligible.

By submitting a Contest Material, each contestant agrees to and irrevocably assigns and transfers to CheapOair any and all rights, title and interest, included but not limited to all copyright and any other intellectual property right throughout the world, that the Contestant has or may have in the Contest Materials provided to Cheapoair or prepared in connection with the Contest in any way, including, but not limited to the contestant's name, voice, image, likeness, photograph, city and state of residence. IV. Winner Selection

On September 4th, 2012, at least 10 semifinalists shall be announced by CheapOair and their Entry Videos will be made available by CheapOair for public voting on the Site. The Entry Videos will be made available for public voting until September 21st, at 5 p.m. (EST) ("Closing

Date").

The two Contestants with the most number of votes for their Entry Videos at the Closing Date will be declared Finalists. If the two Finalists cannot be distinguished by the number of votes, then CheapOair will select them from the contestants with the most votes or, at Cheapoair's discretion, extend the Closing Date until the Finalists can be distinguished.

The two Finalists are subject to verification of eligibility and compliance with these Terms and Conditions. If a Finalist is disqualified for any reason or cannot participate in the Final Round, he or she will be replaced by the follow-up contestant with the most number of votes, at CheapOair's sole discretion.

Each of the two Finalists shall be awarded the opportunity to participate in the Final Round. In the Final Round, each Finalist will be provided the opportunity to travel to a foreign destination as determined by CheapOair and to stay at that destination for a maximum of 30 days. For this purpose, CheapOair will provide each finalist with a round-trip ticket to such destination, and with a daily Allowance, up to an aggregate maximum of \$7500 for the entire Travel Period. The Allowance shall be used primarily to pay for his or her stay at a hotel, for food and other travel related expenses.
